This organization's membership has exceeded 600 Fairies!

As we celebrate the 7th year mark of our organization, you may reflect on the accomplishments by viewing the historic timeline on our website at www.fgfund.org. The timeline gives a review of the past seven years, month by month. The archives present pictures of many successful Lingerie Luncheons, our charitable golf tournaments as well as other milestones for the Manhattan Fairy Godmothers. Wishes Granted!

Struggling to live on disability an older woman does not have money for unexpected expense. Her furnace went out and had to be replaced. She used the money that she had set aside for her car insurance to pay for it. Her car insurance was past due and she received a grant to make it current and for one more month.

Squeezing by on Social Security income, an elderly woman also supports her middle aged son because he is mentally disabled. She owns her own home but her well pump was broken and she did not have any running water. The grant covered the cost to repair and replace the well pump.

A young mother of six children is currently attending classes to get her GED in order to get a job. She asked the Fairies for help in repairing her car so that she could get to class, school and doctor's appointments.

Due to her low income an older woman was unable to afford ATA bus tickets and she does not drive. She requested a supply of ATA tickets so that she could get to and from her doctor appointments.

A single mother with no health insurance was concerned about her eyesight because she had a significant commute to work. A grant provided her with an eye exam and contact lenses.

Health issues caused a woman to have her hours cut at her job. She lost her apartment and is living at the Emergency Shelter. Her health has improved and she can now work full-time but needed to have repairs to her car so that she could get to work.

Due to diabetes a woman was prescribed the use of diabetic shoes and inserts. The cost for those was significantly more than what the patient was able to pay. A grant for them supported the woman's efforts to gain employment and function on a daily level.

The furnace in a woman's trailer home needed to be replaced as the cold days set in. She lives on a disability income. The heating company gave her a special price so that she could pay for the furnace with our help.

A local dentist agreed to rebase a woman's lower dentures. Without our help, she would have run into possible health issues because she could not chew.

We were able to help a woman get a Protection from Abuse order by paying part of her legal fees for the hearings. The legal firm capped their fee because of Fairy Godmothers willingness to help. They were able to work out a payment schedule for the woman to pay the remainder.

Without a washer and dryer, a mother of three children was spending a lot of money at the laundromat. An agency was able to locate a used washer and dryer set and the Fairies were able to purchase the machines for her.

A young woman has two children. She and her husband both work, but have fallen behind because the woman hurt her ankle and could not work for several weeks. At that point, their water heater failed. After getting financial counseling from an agency in town, Fairy Godmothers were able to replace their water heater. The plumbing company lowered their price so that we could pay the entire bill.

Fairy Godmothers paid a young woman's tuition bill for her Business Administration Certificate at MATC so that she could get a better job to support her family.

A woman who was born with a severe handicap had surgery and needed a Homecare and Hospice Healthcare Attendant to come to her home and assist her with bathing, housekeeping, and meal preparation. She lives in an apartment connected to her mother's house, but her mother was out of town. Fairy Godmothers were able to provide her this much needed assistance.

Our grants have been primarily for car related items. It is rewarding to be able to help get these women on the road again. We want to extend a special thanks to Burnett Automotive for giving the Fairy Godmothers a generous discount on automotive services. We have added CASA to our list of cooperating agencies allowing us to help more women in new ways. When you consider the women we help and the impact we have made on the community in the six years we have made grants, it is tremendous. Thank you to all the Fairy Godmothers and their continued support of the Grants Committee!
